



2nd Annual Nonprofit Organization of the Year Award 2024 Application

Purpose: The Chamber's Nonprofit of the Year Award recognizes nonprofit organizations, which are a vital part of our economy and community. The Chamber acknowledges, with a membership over 10% represented by nonprofits and educational organizations, that these businesses hire personnel, purchase goods and services, and move the economy in the same way that for-profit businesses do. The award is presented to the small nonprofit and large nonprofit that demonstrate business success, community involvement, sustainability, and excellent customer relations.

Criteria: Nominated organizations must be a member of the GGCC, and must have had a continuous membership for at least 1 year prior to the application deadline.

Small Nonprofit category:

Organization must have less than ten (10) full-time (FTE) employees (same as the GGCC Small Business of the Year category). Annual operating budget must be less than \$2MM. You must fill out this application completely. Incomplete applications will not be considered.

Large Nonprofit category:

Organization must have at least one paid w2 employee. Annual operating budget must be more than \$2MM. You must fill out this application completely. Incomplete applications will not be considered.

Decision: The winners of the Nonprofit of the Year awards will be determined by a member committee review of the applications.

Application Deadline: The nomination deadline will be at **Noon on Thursday, August 8, 2024**, emailed to pross@ggchamber.org. The awards will be presented at *Picnic with a Purpose* on September 12th at Smokey Glen Farm. Award winners will also be recognized at the Annual Gala in December.

Small Business of the Year winners from the past 5 years are not eligible.
